# **Opening business**

## Report of the Chair/Representative

- F. University Senate Nothing to report; Senate has not met since last C&C meeting
- G. Senate Exec Apropos of Sally Reis's motion to the Senate about transfer credits for students enrolled at UConn as freshman, this committee will explore the process of certifying transfer courses for UConn equivalency, and whether there is a performance differential between students who earned a prerequisite credit elsewhere vs here at UConn.
- H. GEOC The committee discussed the issue of CAR form completion policies for so-called 'minor' revisions to courses and decided that the form must be completed for any and all changes. Almost immediately an exception presented itself; the LAMS and PRLS course codes are being retired and will be replaced with LLAS; using the precedent of the change from WS to WGSS, the GEOC and Senate C&C Chairs decided to allow the change to go ahead without requiring individual CAR forms for each affected course. Discussion of the CAR form sparked questions from the Senate C&C about if/how course requests are archived. K. Labadorf pointed out that UConn does have a university archivist at the Dodd Center, and it was also suggested that Tammy Gifford might have some insights on this. K. Piantek will follow up.

- J. Curriculum Advisory ("workflow") group E. Schultz, M. Darre, and K. Piantek beta tested the "add course" form draft and found some minor issues and some wording corrections, but were mainly satisfied with the initial product; they will work on adding "help"

fields to relevant parts of the form and asked Senate C&C members to try the new form and/or look at the old form to evaluate the usefulness of current help fields; K. Labadorf indicated that she would like to try the form, so K. Piantek will ask Mike Oatley to give her access.

1. Motion # **SENCC1314-57** (M. Darre, M. Buck) BME 2101 Introduction to Biomedical Engineering (prerequisites, co-requisites and course description)

BME 2101. Introduction to Biomedical Engineering.

(210) (Formerly offered as BME 3101.) Three credits. Prerequisite: BIOL 1107; open only to Biomedical Engineering majors, others by instructor consent. Corerequisite: PHYS 1501Q and MATH 2110Q.

Survey of the ways engineering and medical science interact. The art and science of medicine, and the process of medical diagnosis and treatment. Diagnostic instrumentation and measurements including medical imaging. Introduction to bioelectric phenomena, biomechanics, and biomaterials. Biochemical engineering. Computers in medicine. Molecular medicine and biotechnology.

BME 2101 Introduction to Biomedical Engineering

Three Credits. Prerequisite or Corequisite: MATH 1132Q; PHYS 1230 or PHYS 1501Q or PHYS 1530Q. Recommended Preparation: BIOL 1107. Open to non-BME majors with Instructor Consent.

Fundamental concepts and techniques of engineering and medical science and their integration. The art and science of medicine and the process of medical diagnosis and treatment. Topics include: diagnostic instrumentation, diagnostic measurements and their interplay; bioelectric phenomena, biomechanics, and biomaterials; biochemical engineering; computers in medicine; molecular medicine and biotechnology; medical imaging.

#### Discussion

Changes made to the wording of the course description by the Chair were approved by the department; it was notes that no grading scale was included in syllabus, and this is recommended as an addition; P. Bedore expressed uncertainty about changes to prereqs (specifically BIOL 1107) where no rationale was included; she wanted to be sure this is what proposers really wanted. The committee reviewed requirements for BME majors, but also recognized that the course can be taken by non-majors, hence the change.

Prerequisite: Instructor consent required; students must have: nine credits of 2000-level or above economics courses (six of which may be concurrent); students must be at least 6th-semester and have a minimum GPA of 2.25 or a minimum of 2.5 in economics courses

at the 2000-level or above; students must secure a satisfactory intern position before the end of the second week of the semester of enrollment in this course; they should begin consultation with the instructor several months in advance. Does not count toward the economics major. Students taking this course will be assigned a final grade of S (satisfactory) or U (unsatisfactory). Supervised field work, relevant to some area of economics, with a business firm, government agency or non-profit organization. Evaluation by the field supervisor and by the instructor (based on a detailed written report submitted by the student).

2481. Internship – Field Study

(294) (Formerly offered as ECON 3481.) Variable credit to a maximum of 6 credits. May be repeated for credit to a maximum of 15 credits. Hours by arrangement. Prerequisite: Instructor consent required; students must have: nine credits of 2000-level or above economics courses (six of which may be concurrent); students must be at least 6th-semester and have a minimum GPA of 2.25 or a minimum of 2.5 in economics courses at the 2000-level or above; students must secure a satisfactory intern position before the end of the second week of the semester of enrollment in this course; they should begin consultation with the instructor several months in advance. Does not count toward the economics major. Students taking this course will be assigned a final grade of S (satisfactory) or U (unsatisfactory).

Supervised field work, relevant to some area of economics, with a business firm, government agency or non-profit organization. Evaluation by the field supervisor and by the instructor (based on a detailed written report submitted by the student).

#### Discussion

The course originally listed no maximum # of credits for repeatability; E. Schultz confirmed with the proposers and department C&C that there was a maximum of 15 credits. Motion **SENCC1314-58** passed.
