# Senate Scholastic Standards Committee 2015/2016

- 1. Welcome
- 2. Minutes from 9/3/15 were approved with small modifications.
- 3. Report back from SEC

Lauren DiGrazia provided an update of SEC discussions.

- a) Composition of Senate standing committees
  Given the purpose of SSSC, SEC agreed that it is desirable to maintain a favorable
  level of representation by faculty. It is also desirable that the committee chair be
  faculty. Moving forward, faculty representation will be taken into consideration when
  populating the SSSC.
- b) Changes at regional campuses
  The standardized schedule will be difficult for regionals to implement on short notice.
  Storrs works on schedules a year in advance, while regionals work 6-12 months in advance. The new requirement will be addressed by Sally Reis or Mun Choi at the September Senate meeting. A second issue was discussed related to clearance for regionals to advertise 4-year degree programs.
- c) SETs stay with FSC SETs will remain in the purview of Faculty Standards, not SSSC. A question was raised about whether SETs are in the By-Laws, as indicated on the OIRE website.
- d) Ratcliffe Hicks changes
  Students who are dismissed for the first time from the University for scholastic reasons may, upon approval, matriculate no sooner than two semesters following dismissal. Given that Ratcliffe Hicks is a 2-year program, a two semester dismissal is relatively long. This will be addressed as a MOU between the Dean of Students and Ratcliffe.

## **Decisions:**

e) Is the length of the Add/Drop period appropriate

The length of the Add/Drop period poses difficulty of faculty of W classes; however,
the perspective of both faculty and students must be examined in considering
shortening the length of time provided. Federal guidelines do not stipulate 10 days;
rather, UConn must inform the feds of its guideline.

## **Decisions:**

Student Welfare should be consulted on this matter.

f) Should taking 4xxx courses be a graduation requirement?

When the University went from numbering courses in the hundreds to thousands, it became possible in certain majors with a broad catalog of classes for students to graduate without taking courses above the 2000's. Should this be addressed by departmental C+C committees or become a University requirement? Are there standards for level of rigor of 2,000, 3,000 and 4,000-level courses?
