I. Opening Business

II. Report of the Chair (E. Schultz for S. Wilson)

- A. University Senate E. Schultz provided a "brief look forward." The Senate will review and then later vote on the proposal for new Gen Eds.
- B. Senate Executive The group has its first meeting this Friday.

III. Other Committee Reports

- A. UICC (M. Hatfield) Nothing to report.
- B. Honors Board of Associate Directors (TBD) E. Schultz will stay on HBAD.
- C. Scholastic Standards (TBD) S. Wilson will be the rep for this committee if no one else volunteers. *Post-Meeting Note: G. Michna later volunteered to be the rep for Scholastic Standards.*
- D. GEOC (M. Wagner) GEOC meets tomorrow. They will talk about W revisions and clarifications. A working group will convene this year to suggest revisions to the Q guidelines. Another working group will meet to help define FYW's place in the Gen Ed curriculum. GEOC will also be working this year to run a robust Provost's Gen Ed Competition featuring incentives for the development of Gen Eds under the new guidelines and courses in Anti-Racism. GEOC has instituted a process for courses that may be declined.
- E. Δ2GE Working Group (M. Wagner) The group collected as much feedback a possible and tried to incorporate as much of it as they could. With the help of Lauren Schlesselman and CETL, they developed language for "objectives" rather than "goals." They will finalize the proposal soon, then introduce it in a special September meeting. The University Senate will vote on it in November.
 - One member had a question about Information, Digital, and Media Literacy (IDML)
 language. There is a page for it on the website, but nothing is listed. M. Wagner noted that they are finalizing the language and the website will be updated soon.
 - One member asked about the student perspective regarding the new Gen Eds. USG has the proposal on their radar, and there is student representation on the task force.

Are there any advising community members on the task force? Yes, Mansour Ndiaye. A
number of advisors also attended the feedback forums. M. Wagner suggested that they
could run a special forum for advisors if there was interest. She asked S. Rusch to reach out
to her.

1.00 credits

Prerequisites: Open only to CE and ENVE majors. Not open for credit to students who have taken CE 2210 or ENVE 2330. May not be taken out of sequence after passing CE 3220.

Grading Basis: Graded

Time value of money. Simple, compound, nominal, and effective interest rate. Present, future, and annual worth methods. Single payment, annuity series, gradient series. Rate of return method. Evaluation of alternative projects.

CE 2211. Engineering Economics I

1.00 credits

Prerequisites: Open only to CE and ENVE majors. Not open for credit to students who have taken CE 2210 or ENVE 2330.

Grading Basis: Graded

Time value of money. Simple, compound, nominal, and effective interest rate. Present, future, and annual worth methods. Single payment, annuity series, gradient series. Rate of return method. Evaluation of alternative projects.

Discussion

- Syllabus feedback from the committee:
 - The syllabus refers to MATH 1122 or 1132 as prereqs but these are not listed in the
 CAR or the catalog copy. Should these be added?
 - Please include learning outcomes and a grading scale as a matter of best practices.
 - The syllabus still refers to the Co-op rather than the bookstore.
 - The syllabus should include the standard language about accommodations and other university policies.
- One member had a question about the course availability to only Engineering majors. Is the prereqs the right place for this restriction? The member had a student who was

concerned about such restrictions. It was noted that this enrollment restriction is fairly common, and the prereqs is generally where is it noted. There may be a better term for it, but adjusting it everywhere would be a very significant change.

• There was discussion of what is required to be in the syllabus, what is just best practice, and whether the syllabus really needs to be as long as it is now.

Prerequisites: Open only to students in Kinesiology programs.

Grading Basis: Graded

3.00 Credits

Prerequisites: None Grading Basis: Graded

This course provides an overview of the five pillars of health (exercise, nutrition, sleep, stress and relationships), specifically emphasizing the role that exercise plays in health promotion and disease prevention across the lifespan by presenting the impacts of exercise in multiple domains including leisure time, culture, community, careers, and the workplace.

Discussion

- Syllabus feedback from the committee:
 - Is the authentication language is needed in the syllabus? If the course is being offered online, yes, but one member did not think the class will be virtual moving forward. The faculty member will be notified that if they intend to continue offering the course online, the language should be added.
 - There was some mention of a virtual conference in 2020. The proposer should be advised to update this.
 - o Including decimals in the grading scale is recommended. (e.g. Is 89.5 a B+ or an A-?)

Motion to revise KINS 1100 (#7079) was passed with one abstention.

3. Motion to revise (K. Fuller, E. Schultz) KINS 2200 Introduction to Athletic Training (#7241 [Revise Pre-regs and description]

KINS 2200. Introduction to Athletic Training

3.00 credits

Prerequisites: Open only to Exercise Science majors with consent of instructor. May not be taken out of sequence after passing KINS 3212.

Grading Basis: Graded

Basic and essential elements of athletic training. Includes discussion of the sports medicine team, legal and research aspects of athletic training, organizational policies, administrative responsibilities, and policies and procedures.

Revised Catalog Copy

KINS 2200. Introduction to Athletic Training

3.00 credits

Prerequisites: None Grading Basis: Graded

This course is an introduction to basic principles of the athletic training profession. Content includes history of the athletic training profession, sports medicine team concepts and applications, environmental influences, health assessment screenings, basic injury and illness assessment, management and treatment, protective equipment, strength and conditioning concepts, and health risks related to the physically active. An overview of athletic training professional organizations and the role the athletic trainer plays in the health care system is introduced. Risk factors associated with blood-borne pathogens (BBP) and common diseases that affect the active population are investigated. Concepts of universal precautions and BBP training will also be provided.

Discussion

- Syllabus feedback from the committee:
 - Weights for assessments and a grading scale are recommended.
 - o It is against university policy to grade on attendance.
- The CAR says the course is repeatable for credit, but members felt that this was not actually the case. Proposers sometimes confuse this question with being able to repeat the course for a higher grade. S. Wilson will verify the intent with the proposer.

Motion to revise KINS 2200 (#7241) was passed unanimously.

Prerequisites: MUSI 3314 and 3321; open to juniors or higher.

With consent of instructor, MUSI 3321 may be taken concurrently.

Recommended preparation: A course in mathematics.

Grading Basis: Graded

Analytical techniques appropriate to selected styles of twentieth century music. Problems in twentieth century counterpoint and composition.

MUSI 3371. Twentieth Century Theory and Analysis

3.00 credits

Prerequisites: MUSI 3314 and 3321; open to juniors or higher.

With consent of instructor, MUSI 3321 may be taken concurrently.

Recommended preparation: A course in mathematics.

Grading Basis: Graded

Analytical techniques appropriate to selected styles of twentieth century music. Problems in twentieth century counterpoint and composition.

Discussion

• There was concern about when the course would lose its Q designation. It was clarified that the course will not lose its designation until the next catalog year. It can be offered in the Spring as Q, but it will no longer carry the Q as of Fall 2022.

- It was noted that the course could be a great service learning course. Please ask the faculty member to reach out to J. Yakovich.
- Yes, GEOC has reviewed the course for CA2.
