MATH 2720. History of Mathematics

3.00 credits

Prerequisites: Either (i) MATH 2110 or 2130, and either MATH 2210 or 2410; or (ii) MATH

2420 or 2144

Grading Basis: Graded

A historical study of the growth of the various fields of mathematics. This course may not be counted in any of the major groups described in the Mathematics Departmental listing.

Discussion

• One member was uncertain about the preregs related to the Honors.

Motion to add MATH 2720 (#12245) was approved unanimously.

VI. Tricky Business: Delta Implementation Document

- The group looked at the document page-by-page.
- The issue of transfer credits from the Community Colleges needs to be figured out. In particular, what Gen Eds will students especially student-athletes be held to? We need to ensure that students will be bringing in Gen Ed classes for the right catalog year, especially during overlap years.
- Trust and buy-in is a really important principle, but it's only mentioned briefly in the document. Can we expand this?
- S. Wilson explained that we can make three recommendations: 1) Create a Task Force, 2) Expand/Streamline GEOC, and 3) Establish a permanent full-time coordinator position.
- There was a suggestion that CT Community College reps should be on the Task Force. There was some push-back here. Having representatives external to UConn would not be a good idea.
- There was discussion of representatives versus constituents who need to be kept in the loop. It will be important to make sure that certain stakeholders are included in the conversation, but they do not necessarily need to be on the Implementation Task Force. These stakeholders should be put under a "Seeking Input" heading.
- One member noted that we need to be very mindful of the size of the Task Force. If it is too big, they will not get anything done.
- One member suggested a newsletter that regularly gets sent to stakeholders to give them updates.
- We need to ensure administrative help for the Task Force.
- There was discussion of intersection with LTE. Maybe there should be some overlapping members between LTE and Task Force.
- There are two ways to think about the inclusion list: people versus areas of attention.
- Equity-mind teaching principles should be added to the guiding principles.

- We need to be sure we are checking the data from the start.
- It was suggested that we put everything in now and worry about making the proposal leaner once we have all the important content.
- There was discussion of development of "Themes," especially from the Registrar's perspective.
- There was discussion of building in a process for review that ensures checks and balances so that any one discipline or area does not overwhelm the new curriculum.
- One member noted that removing C&C review was not an option. Some members of some committees would be up in arms.
- If we merge committees, we again need to be mindful of size.
- There was a suggestion that some courses could be pre-approved and put on consent agendas. The Task Force could thus do a lot of the work for departments. An important first step would be pre-alignment, even if it takes 6-8 months.
- Having a body of courses ready to align when this goes live is critical.
- There is lots of change going on right now. There was concern that adding a big change like restructuring GEOC might only create problems.
- Members were supportive of the fulltime position recommendation. There were questions about where this position will reside and who it would report to.
- Members were supportive of a higher-level position. "Don't cheap-out on this position."
- One member noted in the chat that the position would be great under CETL.

VII. Elusive Business

- A. Questions and Concerns about 'Popup Courses'
 - 1. What are the C&C review requirements? (Note: Variable Topics courses do not need review beyond the department, but Senate C&C has continued to review popup courses.)
 - 2. How credits are accounted for related to graduation credits? (Note: Students can currently earn up to 6 credits.)
 - 3. Who can offer these courses?
 - 4. Proposed motion from David Knecht: "No course can be offered for credits that count toward graduation unless it is reviewed by a faculty college C&C committee."
