# Annual Report to the University Senate AY 2022-2023 Senate Scholastic Standards Committee

The presentation below contains a Summary of SSC actions and a brief synopsis of each SSC action presented to the Senate.

**Summary:** Scholastic Standards approved and presented three motions to amend the By-Laws, Rules, and Regulations of the University Senate during the 2022-2023 AY. One of these motions, Academic Renewal, was passed. A second motion addressing Academic Misconduct was tabled; this motion will be presented again for a second vote during the May 1 Senate Meeting. The third motion addressing the mid-semester report will be put forth for a vote during the May 1 Senate Meeting. The SCC also nominated and approved a new member to serve on the Honors Board, in addition to recommending the SEC to appoint a sub-committee or task force to study the CSD accommodations issue.

## February 6, 2023

The SSC presented two motions for discussion to amend the By-Laws, Rules, and Regulations of the University Senate as follows:

- 1. Academic Renewal Policy: Section II.B.12, Readmission
- 2. Academic Misconduct: Section II.D,11, Cheating Student Academic Misconduct

#### March 6, 2023

The SSC presented two motions for voting to amend the By-Laws, Rules, and Regulations of the University Senate as follows:

- 1. Academic Renewal Policy: Senate II.B.12, Readmission
  - The vote on the motion passed; 67-yes, 0-no, 0-abstentions.
- 2. Academic Misconduct: Senate II.D,11, Cheating Student Academic Misconduct
  - The vote to table the motion passed; 30-Yes, 20-No, 4-abstentions.

## April 3, 2023

The SSC presented a motion for discussion to amend the By-Laws, Rules, and Regulations of the University Senate as follows:

#### May 1, 2023

The SSC will present two motions for voting to amend the By-Laws, Rules, and Regulations of the University Senate as follows:

- 2. Midterm Grade Warnings: Senate, II.E.6, Scholastic Standing, Mid-Semester and Semester Reports

#### Pending Agenda Items for Fall 2023:

- 1. Temporary grades: The sub-committee tasked with clarifying the policy will present its recommendations to define how the following grades—"N," "X," and "I"—should be assigned.
- 2. CSD Accommodations: A sub-committee will be formed and tasked with reviewing how the CSD makes decisions to accommodate student testing needs and what resources may be required to make such accommodations implementable for both CSD and instructors.
- 3. Experiential course renumbering: The sub-committee will share the progress of policymaking, as SCC approval is not needed.
- 4. Military transfer credits: The sub-committee will share the progress of policymaking, as SCC approval is not needed.
